The First Nation, Inuit, Metis Urban and Rural Housing program (FIMUR) was designed with priorities for tenant selection derived from consultations with the off-reserve Aboriginal community. This priorities are:

- Singles/Seniors who have no other alternative but to turn to emergency shelters to escape violence or any other type of physical or mental grief by their spouses/partners, or other family members with whom they reside and from whom they intend o separate permanently
- Singles/Seniors that are without or to be without housing by no fault of their own whose residences have been destroyed and have no place to live, landlords who have sold the property and have had their tenancy terminated, individuals who have been released from hospital and cannot return to their former residence.
- Singles/Seniors living in crowded situations.
- Singles/Seniors currently living with hazardous conditions.
- Current residence of Social Housing
